Motion by Klarich to approve the above consent agenda. Supported by Lehman. Motion carried unanimously.

7. BUSINESS:

- A. JPJ Invoice #4 CIP. Discussion. Approve/Reject. Mayor Klarich stated that this invoice covers design phase work & bidding services for the City's upcoming project. Motion by Milich to approve JPJ invoice #4 in the amount of \$88,000. Supported by Kuechle. Motion carried unanimously.
- B. Wellhead Protection Public Meeting. Discussion. Approve/Reject. Clerk Pervenanze stated that in 2018 the City started the process of updating our wellhead protection plan. Part of this process includes a public hearing with a consultant from Minnesota Rural Water. Motion by Lehman to hold the wellhead protection public information meeting during the April 7th regularly scheduled Council meeting. Supported by Kuechle. Motion carried unanimously.
- C. Election Judge Appointment. Discussion. Approve/Reject. Clerk Pervenaze stated that the City is still looking for a few more election judges for the August primary & November regular elections. Motion by Lehman to appoint Shari Swanson as an election judge. Supported by Kuechle. Motion carried unanimously.
- D. Grader Blade Purchase. Discussion. Approve/Reject. Clerk Pervenanze stated that recently the City placed a bid for 66 7' grader blades through a St. Louis County Auction. The City was awarded the bid which will result in a savings of \$4,335

- compared to our current supplier. Motion by Lehman to approve the purchase through St. Louis County in the amount of \$5,400, Supported by Kuechle. Motion carried unanimously.
- E. City Owned Land Offer. (Closed Session). Motion by Kuechle to go into closed session. Supported by Lehman. Motion carried unanimously and the Council went into closed to discuss an offer on City owned property location across from the cemetery. Motion by Kuechle to come out of closed session. Supported by Lehman. Motion carried unanimously. No action was taken.

- Councilor Lehman stated that the Minnesota Association of Small Cities is active in St. Paul for the legislative session. They are promoting numerous actions that will support small cities. Council Lehman also stated that there is an upcoming RAMS meeting.
- Mayor Klarich stated that the City has a meeting in St. Paul with Rep. Sandstede to discuss the City's bonding request. The goal of this meeting will be to try and have a hearing scheduled in front of the House Finance Committee regarding the City's bonding infrastructure request. Senator Tomassoni along with Gary Cerkvenik & Jeff Anderson are working on the City's request as well.
