## 6. BUSINESS:

- A. Convene as the Canvassing Board to Review and Certify the Results of the 2024 Municipal General Election and Adopt Resolution 24-28 Canvassing the Results of the November 5, 2024 Municipal General Election.

The City is the administrator of the State General Election, which was conducted and held on Tuesday, November 5, 2024.

As such, state statute requires that the City meet as a canvassing board and declare the results of the state and municipal general election between three (3) and ten (10) days following open voting.

The results of the election are final, and the City will declare the results of the Municipal General Election conducted on November 5, 2024.

441 people voted in the Municipal General Election, with a total of 646 registered voters as of 7:00 a.m. on Election Day, with 47 persons registered on Election Day, and 125 regular, military, and overseas absentee and mail ballots accepted.

In the races for Councilmember, the candidates with the greatest number of votes were:

Taunya Teska-Erickson - 317 votes; and  
Renee Loeffler - 250 votes.

In the race for Mayor, the candidate with the greatest number of votes was:

Jim Matthews - 274 votes.

Resolution 24-28 has been prepared to declare and certify the results of the 2024 Municipal General Election.

**Recommendation is to review and certify the result of the 2024 (State) Municipal General Election.**
